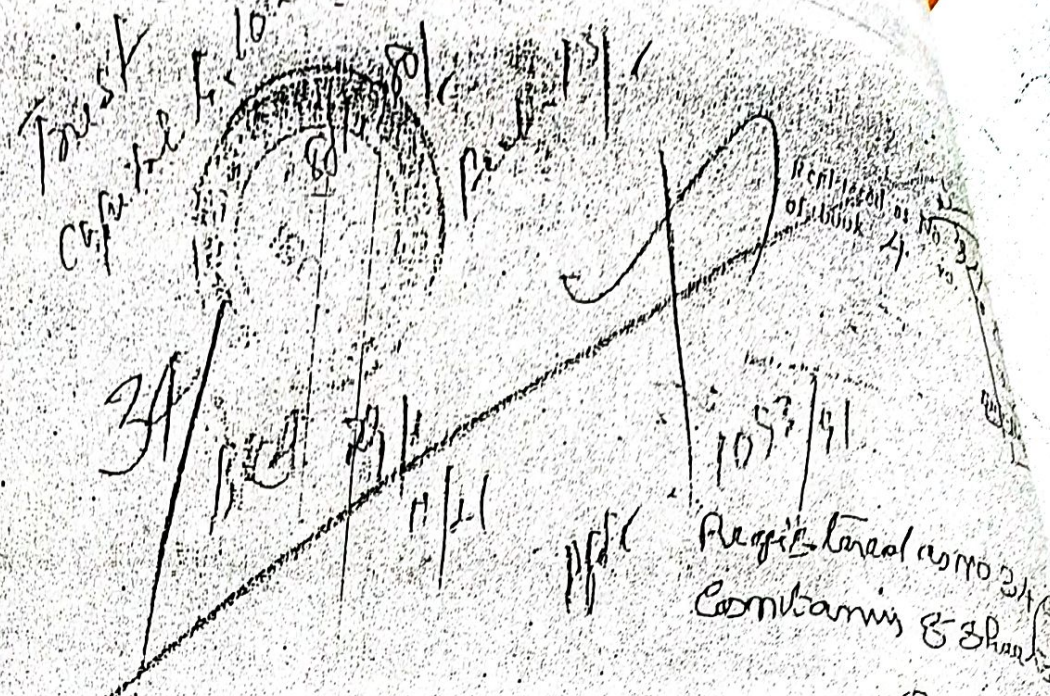

5. To do all acts to improve the standard of living and thereby better the atmosphere of the downtrodden in and around Tiruvannamalai district and surrounding districts if possible, all over the country.

6. To purchase, sell, transfer, procure, construct, manufacture, lease, acquisition of rights of or in any property for facilitating any of the above objects or for the benefit of the society at large.

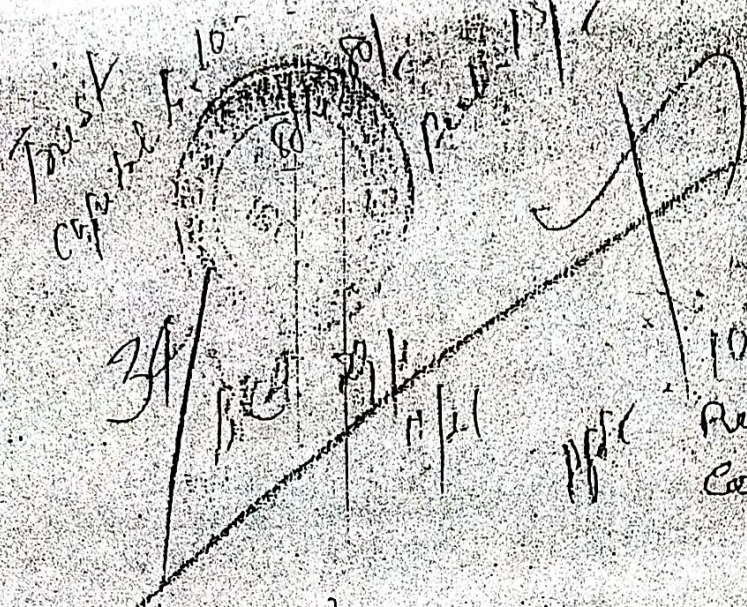

The five trustee nominated by ^{her} (him) shall hold office for life. The Founder Trustee shall have power to nominate more trustees from time to time for such period or periods, as the nomination may provide and the Founder Trustee will also have the power to remove such trustees so nominated by her before the expiry of the period for which they were nominated.

8. (i) The Founder Trustee shall be the Managing Trustee.

(ii) The Founder Trustee/Managing Trustee shall open the bank accounts wherein shall be deposited all money and contributions received by the Trust and maintain the bank accounts. The Managing Trustee shall cause to be maintained proper books of accounts required by law and therein shall be entered a true record of receipts and expenditure of the Trust. The books of accounts shall be subject to audit periodically by a qualified Chartered Accountant.

(iii) The Founder Trustee/Managing Trustee shall be the person to act for and on behalf of the Trust and to open and operate independently the bank accounts and to receive and to pay moneys on behalf of the Trust.

(iv) The Founder Trustee/Managing Trustee shall have power to borrow funds, for implementing and carrying out the objects and purposes of the Trust from banks or other financial institutions on the security or without security on such interest prevailing in the banking institutions and to execute necessary security documents on behalf of the Trust for such borrowings.

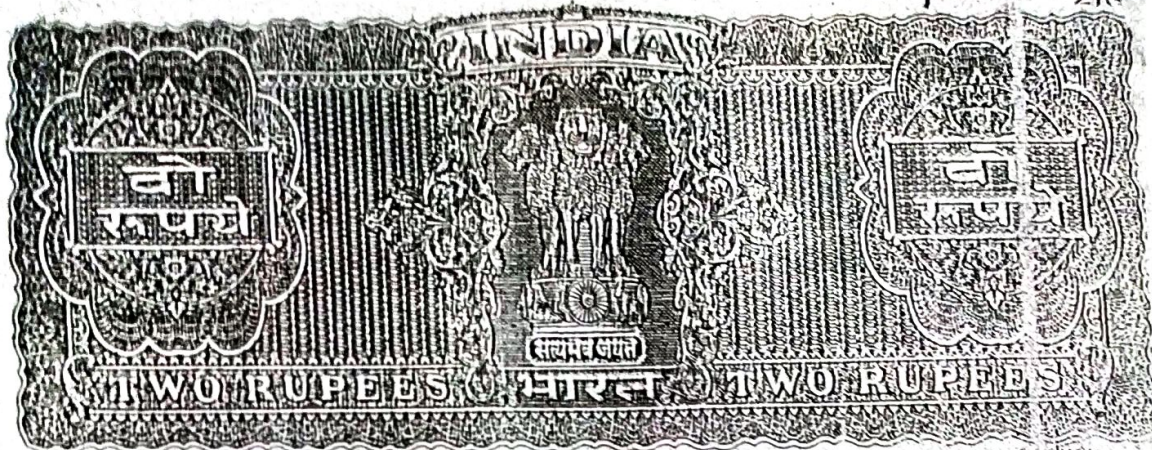

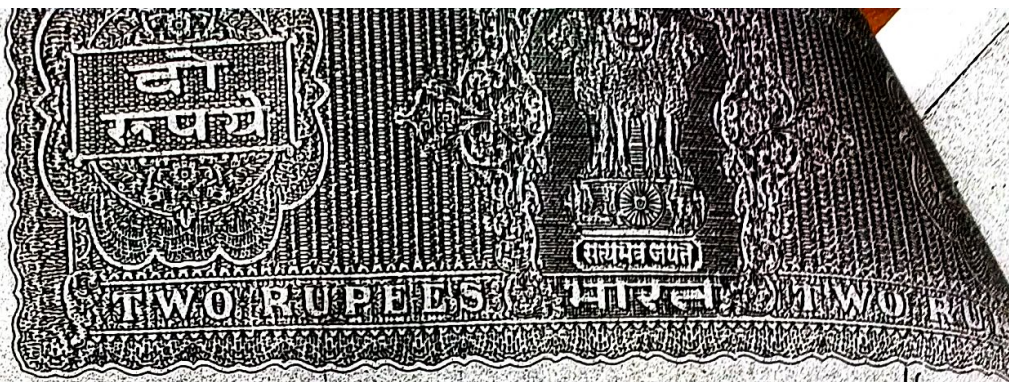

(ix) The Founder Trustee/Managing Trustee shall be entitled to enter into any agreements or covenants with owners or person, entitled, to or interested in any other properties and raise funds by way of loans by entering into agreements with Bank, Tiruvannamalai.

(x) The Founder Trustee/Managing Trustee shall have power to make donations from the Trust properties to carry out the object of the trust and not contravening, clauses herein above.

(xi) The books of accounts shall reflect all receipts and payments either in cash or in kind at all points of time. The books of accounts shall be closed on 31st March of every year and books shall be audited by a qualified Chartered Accountant duly appointed by the author of the trust.

(xii) The Managing Trustee shall cause a sub-committee to be formed and thereby inspect the day of day running of the activities of the Trust.

(xiii) The Trust shall received donations in cash or in kind or any other form and the Trust shall issue valid receipts for the same.
